Processing of personal data

SAACKE processes your personal data in order to enable you to work with us as easily, conveniently and efficiently as possible.

Within the framework of negotiating and fulfilling contracts, and the documents such as invoices, reminders and those relating to the processing of service inquiries (e.g. via our service hotline) and complaints that ensue, we process information about the names, contact data and job titles of our contacts in your company together with the content of any correspondence and the minutes of meetings.

This also applies to the organization of training services and any related documentation for which we need the names of the participants and the training courses attended.

The basis for this is Art. 6 (1) letters b, c and f of the General Data Protection Regulation (GDPR).

In the interests of efficient contact management and to ensure that we can be reached, we not only store telephone numbers but also connection data from previous attempted telephone calls.

We use products from Microsoft Corporation for online meetings, e-mail communication and project planning among other things. You can find more information on this under "Use of Windows 10 and Microsoft 365". The legal basis for this is Art. 6 (1) letter b of the General Data Protection Regulation (GDPR).

If you are already a customer, we use your (postal and electronic) contact data for information and advertising purposes as well as for customer satisfaction surveys. You can object to this type of use at any time in writing, by email or by telephone.

Recipients

Sometimes it is necessary that names, contact data, job titles and content agreements are also forwarded on to third parties, e.g. other customers, plant operators or suppliers.

This is carried out on the basis of Art. 6 (1) letter f of the GDPR with the legitimate interest in ensuring smooth cooperation with customers or operators, e.g. for coordination purposes or to secure access rights to the facilities.

This may also include recipients in countries outside the EU that may not offer an adequate level of data protection. The forwarding of such data will only take place with your agreement and for the purposes of your legitimate interest on the basis of Art. 49 (1) letter c of the GDPR.

We use carefully selected service providers (processors) to assist us with our information and communication activities, to ensure optimum availability of our service hotline and to delete data in accordance with data protection regulations.

Within the scope of the data protection obligations defined in the GDPR, the involvement of the data protection officer (and, in some cases, additionally of the group data protection officer) is necessary. In this context, it is possible that the aforementioned data protection officers may become aware of personal data in the course of their activities. This is particularly the case during training sessions, in discussions with department heads when preparing the necessary documentation, in the event of inquiries from data subjects or when checking the lawfulness of the processing of personal data.

Deletion of data

We delete your data as soon as they are no longer required for the purpose of processing and there are no legal obligations to store the data. This can mean a storage period of up to ten years (e.g. information on invoices) or up to 30 years if the data relates to product liability issues.

Use of Windows 10 and Microsoft 365

We use the Windows 10 operating system and Microsoft Office 365, which we use, among other things, for effective and timely communication and task planning using the Teams, Outlook and Planner apps.

Microsoft 365 is software from Microsoft Corporation, One Microsoft Way Redmond, WA 98052-6399 USA.

Microsoft also processes your personal data in the USA. A user account must also be created in order to use Teams. Microsoft reserves the right to process customer data for its own business purposes. This poses a data protection risk for Microsoft Teams users.

We have concluded data protection agreements and EU standard contractual clauses with the provider Microsoft to guarantee a minimum level of data protection. In addition, we have minimized the data transferred to Microsoft as far as possible through appropriate default settings.

We have no influence on Microsoft's data processing activities. To the extent that Microsoft processes personal data in connection with Microsoft's legitimate business operations, Microsoft is the data controller and as such is responsible for compliance with all applicable laws.
